**REPORT OF THE COMMITTEE OF SELECTION ON THE  
COMPOSITION OF THE BUSINESS COMMITTEE AND  
APPOINTMENTS COMMITTEE**

**1.0 INTRODUCTION**

In accordance with Article 103 of the 1992 Constitution and Order 151 (1) of the Standing Orders of the House, the Committee of Selection was appointed on Tuesday, 10<sup>th</sup> January, 2017 to compose the Standing, Select and Other Committees of the House.

Pursuant to Order 151 (2) of the Standing Orders of the House, the Committee met on Tuesday, 10<sup>th</sup> January, 2017 and composed the Business Committee and Appointments Committee in accordance with Orders 160 and 172 respectively.

**2.0 DELIBERATIONS**

In its deliberations, the Committee was guided by the formula adopted by the House on Tuesday, 10<sup>th</sup> January, 2017 for the Composition of Membership of Committees, Parliamentary delegations and other Parliamentary groups and associations.

The Committee was also guided by Article 103 (5) of the 1992 Constitution and Order 154 of the Standing Orders of the House which require that the composition of the Committees shall as much as possible, reflect the different shades of opinion in Parliament.

**3.0 RECOMMENDATIONS**

The Committee after thorough deliberations recommends as follows:

- i) Considering the urgency of the Business Committee and Appointments Committee in facilitating the business of the House and that of Government, the Committee composes the membership of the two Committees to the House for approval;
- ii) That the Committee would subsequently submit the list of Chairmen, Vice Chairman and other Members of the remaining Committees; and


### 4.0 CONCLUSION
