THE WAIVER OF IMPORT DUTIES AND TAXES ON MATERIALS AND EQUIPMENT INCLUDING OTHER RELATED TAXES FOR THE PORT OF THE TAKORADI INFRASTRUCTURE DEVELOPMENT PROJECT ENGINEERING, PROCUREMENT AND CONSTRUCTION OF PHASE 1:

BREAKWATER EXTENSION, BULK ORE JETTY CONSTRUCTION AND DREDGING

18th
JULY, 2013

1. ACTION REQUIRED

Hon. Members of Parliament are respectfully invited to consider and approve the waiver of of Customs Duty, VAT, EDIF, ECOWAS Levy, Destination Inspection Fees, Withholding Tax Liabilities on Local and Foreign suppliers, Corporate Income Tax and other project related imposts amounting to **Twenty Six Million, Seven Hundred and Eleven Thousand, Eight Hundred and Sixty Five Euros (€26,711,865.00)** to undertake the Design, Civil and Engineering works at the Takoradi Port, Ghana.

It may be recalled that Parliament at its Eleventh Sitting of the Emergency Meeting held on Monday 17th September 2012, approved by Resolution the said Credit Facility Agreement between Ghana Ports and Harbours Authority (GPHA) and KBC Bank NV, Belfius Bank SA/NV, Deutsche Bank AG, London, Fortis Bank NV/SA, and ING Belgium NV/SA with the Government of Ghana as the Guarantor.

2. BACKGROUND

The Takoradi Port has recently become the focus of maritime trade activities especially in support of the emerging oil and gas cluster of services and activities.

The rapidly growing economy coupled with the emerging oil and gas industry has necessitated the demand for modern shore-based support services and facilities for important activities such as storage and handling of chemicals; lifting and storage of heavy equipment in thousands of tons in single lifts; fabrications and spooling activities for rigid production flow pipes, water and gas injection flow pipes; berthing of multi-purpose platforms, supply and light construction vessels; fabrication, assembly and repair yards; oil rig repair facilities; container yards for project cargo such as spares, food and medicals for the oil fields and the supporting industries among others.

Unfortunately, the Takoradi port has not received the needed attention over a long period to be ready for the emerging new operational requirement and activities. Various Master Plan studies have been undertaken but have failed to adequately predict the current needs of the Port. The port therefore has to provide adequate berthing, mooring, wharf, warehousing and large open space facilities at the waterfront in response to the above stated demands.

Further, due to the shallow depths of the Port, the shipment of bulk cargos including cocoa, and other agro-forestry products is by double-handling through the use of old-fashioned lighterage system. With the emerging growth prospects and global competition, the economies of scale would require the use of larger vessels and direct loading facilities to sustain reasonable economic growth.

2. The Project

The twin city of Sekondi-Takoradi has a relatively shorter route by rail to the middle belt of Ghana and thence to the landlocked countries of Burkina Faso, Mali and Niger. The port therefore offers an excellent opportunity for the use of the Ghanaian corridor to capture containerized and general cargo transit trade to these landlocked countries, which had traditionally been kept within the corridors of Ghana's neighbours.

Within the framework of the development scenario described above, the Government of Ghana (GoG) acting through the Ministry of Transport with GPHA as the implementing agency intends to engage the services of a port and maritime construction firm, *Jan de Nul of Belgium* to undertake dredging and civil works within the Port of Takoradi as a major step towards the re-development and expansion of Takoradi Port.

GPHA, after several considerations, has prepared a Master Plan layout and conceptual designs intended to guide in the expansion of the port. Central to this Master Plan's phase development is the plan to relocate the bulk handling activities outside the main harbour basin into deeper waters to eliminate the rail/road intersections and provide space for other cargo handling and storage activities in an efficient manner, particularly for the admission of oil and gas service terminals.

Further, the port in its current state lacks the requisite infrastructure such as good access roads, paved areas for the handling of cargo, paved parking areas for imported vehicles and port haulage trucks, sheltered storage facilities, utilities services, etc. The influx of the oil service vessels and other oil and gas related activities therefore place the port in a desperate state of *need*. The project is thus expected to help address some of these challenges and bottlenecks.

3. SCOPE OF THE PROJECT

The proposed works is considered under the portfolio of an Engineering, Procurement and Construction contract (EPCC). The following stages are highlighted:

4. Design Stage: The Engineering Design, guided by the Employer's Requirements will be conducted by the Contractor. The complete gamut of technical feasibility checks, site data collection, simulations, and detailed designs based on the geophysical and hydrological conditions of the port area and the entire agreed port infrastructure would be conducted.

The designed system including all the force and interactions between waves, currents, tides, sediments, geotechnical and foundations safety of all physical structures (natural and man-made), air and water quality, environmental parameters, design vessel manoeuvrability, operations and navigations, weather scenarios, etc., would be verified and simulated completely to confirm the design details and structural safety for the Employer's approval.

Another important feature is to secure the design insurance for the works to be borne by the contractor. Such design insurance can only come from an insurance provider who is convinced about the soundness of the design, hence the need to have a comprehensive design study to cover the scope of the works. After the completion of the environmental impact assessment study of the construction and dredging works, the contractor is expected to register an acceptable environmental management plan (EMP) and certification for the works.

5. Construction Stage: This sub-component will cover the construction works, including, but not limited to the following:

- a. Dredging in soft rock to provide water depths of up -14m (or depending on the geotechnical investigations, -16m water depths) in the harbour basin and port access / navigation channel;
- b. Reclamation works;
- c. At least, 400m of concrete quay wall for bulk mineral ore terminal operations;
- d. Breakwater extension of 1150m of rubble-mound / concrete blocks breakwater;
- e. Rock armour revetment, approximately 1800m, to protect reclamation areas;

The complete works, including the Technical and Feasibility Studies and Detail Designs plus Construction and Dredging Works shall be executed with One Hundred and Ninety-Seven Million Euros (€197,000,000.00).

4. OBLIGATION OF THE GOVERNMENT OF GHANA


Under the Irrevocable and Unconditional Guarantee on first demand signed on 3rd October, 2012 between the Government Republic of Ghana acting through the Ministry of Finance (Guarantor) and the Finance Parties and Security Agent, the Government of Ghana commits under clause 23 of the Agreement to bear all costs and expenses related to the enforcement of this Guarantee.

Further, under Article 1.13 of the commercial contract/Particular conditions of the Contract of the first amendment to the contract for Port of Takoradi Infrastructure Development Project, dated 19th June, 2013 which was entered into between the Ghana Ports and Harbours Authority (Government

representative for the Ministry of Transport) and Jan De Nul N.V / Jan De Nul Ghana Limited (Contractor/Additional contractor), the Employer commits to use its best efforts to exempt the Contractor, Additional Contractor from Custom Duties, Internal taxes and other fiscal levies which may be imposed in the Republic of Ghana with respect to the supply of products, services and equipment necessary for the Works. Should any of such tax be payable by the Contractor, Additional Contractor such amounts shall be reimbursed by the Employer to the Contractor.

5. RECOMMENDATION

In view of the requirement of the Contract Agreement and within the framework of Article 174 (2) of the Constitution, Hon. Members of Parliament are kindly requested to consider and approve the waiver of Corporate Income Tax, Customs Duty, VAT, EDIF, ECOWAS Levy, Destination Inspection Fees, Withholding Tax liabilities on Local and Foreign Suppliers, and other related taxes as assessed by the Ghana Revenue Authority for the Civil and Engineering Works at the Takoradi Port excluding the Corporate and other withholding taxes amounting to **Twenty Six Million, Seven Hundred and Eleven Thousand, Eight Hundred and Sixty Five Euros (€26,711,865.00)**.

Parliament at its Eleventh Sitting of the Emergency Meeting held on Monday, 17th September 2012, approved by Resolution the Credit Facility Agreement between Ghana Ports and Harbours Authority and KBC Bank NV; Belfius Bank SA/NV, Deutsche Bank AG, London, Fortis Bank NV/SA, and ING Belgium NV/SA, with Government of the Republic Ghana as guarantor, for an amount of One hundred and ninety-seven million Euros (€197,000,000.00) to finance the design, civil and engineering works at Takoradi Port, Ghana..

I am directed to forward to you the text of the Resolution as follows:

WHEREAS

1. By the provisions of article 181 of the Constitution and Sections 3 and 7 of the Loans Act, 1970 (Act 335), the terms and conditions of any loan raised by the Government of the Republic of Ghana on behalf of itself or any public institution or authority shall not come into operation unless the said terms and conditions have been laid before Parliament and approved by a Resolution of Parliament;
2. Pursuant to the provisions of the said article 181 of the Constitution and Sections 3 and 7 of the Loans Act, 1970 (Act 335), at the request of the Government of the Republic Ghana acting through the Minister responsible for Finance and Economic Planning, there has been laid before Parliament the terms and conditions of the Credit Facility Agreement between Ghana Ports and Harbours Authority and


KBC Bank NV, Belfius Bank SA/NV, Deutsche Bank AG, London, Fortis Bank NV/SA, and ING Belgium NV/SA, with Government of the Republic Ghana as guarantor, for an amount of One hundred and ninety-seven million Euros (€197,000,000.00) to finance the design, civil and engineering works at Takoradi Port, Ghana.

THIS HONOURABLE HOUSE HEREBY RESOLVES AS FOLLOWS:

In accordance with the provisions of the said article 181 of the Constitution and Sections 3 and 7 of the Loans Act, 1970 (Act 335) this House approves the Credit Facility Agreement between Ghana Ports and Harbours Authority and KBC Bank NV, Belfius Bank SA/NV, Deutsche Bank AG, London, Fortis Bank NV/SA, and ING Belgium NV/SA, with Government of the Republic Ghana as guarantor, for an amount of One hundred and ninety-seven million Euros (€197,000,000.00) to finance the design, civil and engineering works at Takoradi Port, Ghana.

**IRREVOCABLE AND UNCONDITIONAL GUARANTEE ON
FIRST DEMAND**

2. Pursuant to clause 20.1 (Appointment and duties of the Agent and the Security Agent) of the Facility Agreement, the Finance Parties have appointed the Security Agent to act as their agent under and in connection with the Finance Documents.
3. The capitalised terms used hereinafter shall have the same meaning as set forth in the Facility Agreement unless defined otherwise. The Guarantor declares to be cognisant of the wording and all the terms and conditions of the Facility Agreement.
4. In consideration of the Finance Parties entering into the Facility Agreement with the Borrower and considering the fact that all liabilities deriving from the Finance Documents, as amended, restated or refinanced in whole or in part from time to time, whether existing or becoming due or arising in future (including the obligation of principal repayment or that of the payment of contractual and default interests, fees, costs or any other sums due to the Finance Parties under any title relating to the Finance Documents), are guaranteed by an irrevocable and unconditional, autonomous and independent first demand guarantee issued by the Guarantor as primary obligor and not as merely surety in accordance with the following terms (the **Guarantee**).
5. The Guarantor expressly agrees that any reference in this Guarantee to the Facility Agreement or any other Finance Document does not affect the intention of the Guarantor and the strictly independent nature of this Guarantee.
6. By way of an irrevocable and unconditional, autonomous and independent first demand guarantee, the Guarantor hereby undertakes, without it being possible to invoke any exception based on the relationship between any Finance Party and the Borrower or on the grounds of the relationship between the Guarantor and the Borrower (or any other instructing party of the Guarantee), to pay to:
 - (a) the Security Agent within ten (10) days after the Guarantor has received written demand from the Security Agent that:
 - (i) the Borrower has defaulted in paying a certain amount under any Finance Document; or
 - (ii) the DSRA's credit balance is lower than the Required DSRA Amount and the Borrower has not timely funded or refunded the DSRA; and
 - (b) each Lender within ten (10) days after the Guarantor has received written demand from such Lender that the Borrower has defaulted in paying a certain amount under clause 7.1 (Mandatory prepayment – Negative Outcome Event) of the Facility Agreement,
- and any such amount that is specified in the written demand as the amount which the Guarantor has to pay pursuant to the Guarantee. All other requirements for a demand prescribed in article 15 of the Uniform Rules for Demand Guarantees (URDG), publication ICC, nr. 758, are excluded.
- Any demand of the Security Agent stating an amount due from the Borrower or the Guarantor shall be conclusive evidence thereof and shall be binding upon the Guarantor.
7. This Guarantee and the rights of the Security Agent and the other Finance Parties hereunder shall not be affected by any illegality, irregularity, unenforceability or invalidity of any obligation of the Borrower or any other person under the Finance Documents or any other agreement (including any action of governmental authority or any exchange control and currency transfer regulations prohibiting the Borrower to pay in conformity with the Finance Documents) to the extent that the Guarantor's obligations under this Guarantee shall remain in full force and effect and this Guarantee shall be construed accordingly as if there were no such illegality, irregularity, unenforceability or invalidity.

EXECUTION VERSION

If at any time the Borrower shall be guaranteed besides the Guarantor by one or more other guarantors, payment of all amounts due under the Guarantee may nevertheless be required from the Guarantor as if it were the sole guarantor.

11. Until all sums owed to the Finance Parties by the Borrower under the Finance Documents have been irrevocably paid in full, the Guarantor shall not, after a claim has been made on the Guarantee hereunder, by virtue of having paid any and all parts of such claim:
 - (a) be entitled to claim or to rank as a creditor senior to or on parity with the Finance Parties towards the Borrower;
 - (b) receive, claim or have the benefit of any payment or distribution from or on account of the Borrower, or
 - (c) exercise any right of set-off against the Borrower or claim the benefit of any Security or sums held by or for the account of the Finance Parties it being acknowledged that the Finance Parties shall be entitled to apply such Security and sums as it sees fit.
12. Where any discharge (whether in respect of the obligations of the Borrower or any Security thereof or otherwise) is made in whole or in part or any arrangement is made on the faith of any payment, Security or other disposition which is avoided or must be repaid on bankruptcy, liquidation or otherwise without limitation, the liability of the Guarantor under this Guarantee shall continue as if there had been no such discharge or arrangement.
13. If, but in the context of a general recovery plan, of which the rescheduling of any Finance Document guaranteed hereunder is a part, the Finance Parties should be requested to accept additional or new commitments and/or grant additional or new loans to the Borrower, the Guarantor hereby agrees to unconditionally and irrevocably guarantee such additional or new commitments and/or additional or new loans on the same terms and conditions as set out in this Guarantee.
14. The Guarantor represents and warrants the following:
 - (a) The Guarantor is fully qualified and empowered to own its assets and carry on business as it is presently being conducted. The Guarantor has full power, authority and legal right to enter into this Guarantee and to execute, to exercise, to deliver and to perform its obligations under this Guarantee;
 - (b) All action required to authorise the execution, the delivery and the performance of this Guarantee have been duly taken (including but not limited to the approval of the Guarantee and the Facility Agreement by the Parliament of Ghana);
 - (c) The person(s) signing the Guarantee on its behalf is/are duly authorised to sign for and on its behalf;
 - (d) Neither the execution and delivery by the Guarantor of this Guarantee nor the performance by the Guarantor of its obligations hereunder will:
 - (i) violate in any respect any provisions of law or regulation or any order of any governmental, judicial or public body or authority, or the laws applicable to the Guarantor, or any mortgage, agreement or other undertaking or instrument to which the Guarantor is a party or which is binding upon it or its assets, nor result in the creation or imposition of any encumbrance on any of its assets pursuant to the provisions of any such mortgage, agreement or other undertaking or instrument, nor

- constitute a default or termination event (however described) under any such agreement or instrument.
- (ii) cause to exceed any limitation on the Guarantor or the powers of its officers, whether imposed by or contained in the constitutional documents of the Guarantor, by any law, order or judgment, by any agreement or instrument or otherwise;
- (e) It is familiar with giving guarantees upon demand and is aware of the particular risk arising out of such guarantees upon demand.
- (f) This Guarantee and the obligations resulting thereof, constitute a legal, valid and binding obligation on the Guarantor, is within its interest and is enforceable in accordance with its terms;
- (g) It complies, in all material respect, with all laws to which it may be subject;
- (h) Other than as set forth in this Guarantee, no registration, recording or filing with, and no (further) authorization from any public authority, from any relevant administrative body or any other person is required by the Guarantor in connection with the validity, execution, delivery or enforceability of this Guarantee;
- (i) Under the law of the Guarantor's jurisdiction it is not necessary that the Guarantee be filed, recorded or enrolled with any court or other authority in that jurisdiction or that any stamp, registration or similar tax be paid on or in relation to the Guarantee except for the stamping required under clause 15 paragraph (e) below.
- (j) To the extent applicable, no Authorisation, and no payment of any Tax and no other action whatsoever which has not been duly and unconditionally obtained, made or taken, is necessary or desirable under the laws of the Guarantor's jurisdiction to enable the Guarantor to lawfully enter into, exercise its rights and comply with its obligations under this Guarantee and to make the Guarantee admissible in evidence in its jurisdiction. To the extent applicable, all necessary Tax returns have been delivered by or on behalf of the Guarantor to the relevant taxation authorities and the Guarantor is not in default in the payment of any Taxes, and no claim is being asserted with respect to Taxes which is not disclosed in the financial statements referred to in this Guarantee.
- (k) The Guarantor has fully disclosed in writing to the Finance Parties all facts related to the Guarantor which the Guarantor knows or should reasonably know and which are material for disclosure to the Finance Parties in the context of the Guarantee.
- (l) No event has occurred which constitutes, or which with the giving of notice and/or the lapse of time and/or the making of a relevant determination would constitute, a contravention of, or default under, any agreement or instrument by which the Guarantor or any of its assets is bound or affected, being a contravention or default which might have an effect on its liability to observe or perform its obligations under the Guarantee and all documents connected therewith
- (m) No action, litigation, arbitration or administrative proceeding or claim which might by itself or together with any other such proceedings or claims have an effect on its ability to observe or perform its obligations under the Guarantee and all documents connected therewith, is presently in progress or pending or, to the best of the knowledge, information and belief of the Guarantor, is threatened against the Guarantor or any of its assets.

Furthermore, the Guarantor has not breached any law or regulation.

15. The Guarantor covenants the following:

- (a) The Guarantor declares that it has complied with all laws and regulations concerning loans obtained abroad and guarantees given, presently in force in the Republic of Ghana. It further undertakes to comply with all future regulations and laws coming into force during the lifetime of the Guarantee.
- (b) The Guarantor, as long as it is indebted under the Guarantee, undertakes to keep the Security Agent immediately informed of any proceeding entered against the Guarantor or concerning its assets which might entail substantial depletion of its assets.
- (c) The Guarantor's obligations under this Guarantee rank and will continue to rank at least *pari passu* with the claims of all its other unsecured and unsubordinated creditors, of the Guarantor, now or hereafter existing, except for obligations mandatorily preferred by law applying to companies generally, and without any preference among them and equally with all other present and future indebtedness and obligations of the Guarantor.
- (d) The Guarantor further covenants that as of the date of this Guarantee and as long as any amount remains outstanding under any Finance Documents and under the Guarantee:
 - (i) it shall effect such registrations and obtain all such authorisations, orders, consents, approvals and permissions which may be required for the fulfilment of any of its obligations hereunder, including in particular all necessary exchange control permissions required in relation to the payment of any sum (whether in the nature of principal, interest, commission, fees or otherwise) under this Guarantee; and
 - (ii) it shall promptly inform the Security Agent of any litigation, arbitration or administrative proceeding filed against it or any of its assets which might materially affect the Guarantor's ability to perform its obligations under this Guarantee, as the case may be.
- (e) The Guarantor covenants that promptly upon the execution of this Guarantee, it shall submit the Guarantee for stamping in accordance with the Stamp Duty Act, 2004 (Act 689) of Ghana and deliver to the Security Agent, the original stamped copy of the Guarantee.

16. All payments to be made by the Guarantor to the Security Agent or any other Finance Party pursuant to this Guarantee shall be made (a) without set-off, counterclaim or condition whatsoever and (b) free and clear of and without deduction or withholding for or on account of, any present or future Taxes, unless the Guarantor is required by law or regulation to make any such payment subject to any Taxes.

In such event, then:

- (a) the Guarantor shall notify the Security Agent promptly as soon as it becomes aware of such requirement;
- (b) the Guarantor shall remit promptly the amount of such Taxes to the appropriate taxation authority, and in any event prior to the date on which penalties attach thereto;
- (c) such payment shall be increased by such amount as may be necessary to ensure that the Security Agent or such other Finance Party receives a net amount which, after deducting or withholding such Taxes, is equal to the full amount which the Security Agent or such other Finance Party would have received had such payment not been subject to such Taxes; and

(d) the Guarantor shall indemnify the Security Agent and the other Finance Parties against any liability of the Security Agent or the other Finance Parties in respect of such Taxes.

Not later than 30 days after each deduction or withholding of any such Taxes, the Guarantor shall forward to the Security Agent evidence satisfactory to the Security Agent that such Taxes have been remitted to the appropriate taxation authority.

The Guarantor agrees, as the case may be, to deliver the forms, documents or certificates to the relevant authorities of the relevant country or to the Security Agent, required or reasonably requested in order to allow the Guarantor to make payments under the Guarantee without deduction or withholding for or on the account of any Tax or with such deduction or withholding at a reduced rate. Any taxes due, if any, pursuant to the Guarantee and arising there from, legally due outside of Belgium, shall be for the account of the Guarantor.

17. The Guarantor, hereby agrees to and expressly authorises the use by the Security Agent and the other Finance Parties of any of its details or any of the information relating to the Guarantee, for commercial purposes such as, but not limited to, mentioning in a tombstone, a track record and/or a brochure published by any Finance Party with respect to its trade finance business.

The Guarantor hereby also agrees to and expressly authorises the Security Agent and the other Finance Parties to make available the information as set forth in the previous paragraph to their Affiliates, whether in Belgium or abroad and this for the same purposes as set forth in the previous paragraph.

The information in question will be stored in a secure manner and may only be processed and consulted by persons entitled to do so for the purposes of their job who are bound by a duty of professional discretion and who act in compliance with prevailing legislation.

In addition, the Security Agent and each other Finance Party is authorised to disclose any information or document relating to the Guarantor or this Guarantee, or any other document relating thereto, to its advisers (legal, fiscal, financial, technical or other advisers). The Security Agent and the other Finance Parties may also, at all times, provide the ONDD with any information regarding its actual and future claims/receivables towards the Guarantor as well as with any information regarding any Security issued by the Guarantor, whether or not in relation to the Finance Documents or any other contract or credit agreement.

The decision as to whether or not to pass on all the above-mentioned information, will be the sole and discretionary decision of the Security Agent or the Finance Parties (as the case may be) without being responsible for any use thereof by the ONDD.

18. This Guarantee shall be governed by and construed in accordance with the laws of the Kingdom of Belgium. This Guarantee is also subject to the URDG.

All disputes arising out of or in connection with this Guarantee shall be finally settled under the Rules of Arbitration of the International Chamber of Commerce and by three (3) arbitrators appointed in accordance with the said Rules.

The location of each arbitration proceeding shall be Paris, France. The arbitration proceedings shall be conducted in the English language.

The Parties to the arbitration shall use their reasonable efforts to conclude the arbitration of any controversy or dispute no later than one hundred and twenty (120) days after submission of such controversy or dispute.

The arbitrators shall include in any award the requirement that the losing Party pays the other Party all reasonable costs, including attorneys fees, incurred during the arbitration, subject to the Arbitration Rules.

19. The Guarantor irrevocably and unconditionally:

- (a) waives any right it may have to claim sovereign immunity for itself or its assets from suit, execution of judgment or any other legal process to which it might be entitled in any action or proceeding with respect to any claim arising out of this Guarantee, or any other type of immunity including immunity from jurisdiction, enforcement, injunctions and all other legal proceedings and relief, both in respect of itself and its assets, and agrees to ensure that no such claim is made on its behalf;
- (b) consents generally to the giving of any relief or the issue of any process in connection with proceedings brought by the Security Agent against the Guarantor in relation to this Guarantee; and


In the light of the amendment the contractor is entitled to all tax exemptions for imported items for the project.

The letter under reference is therefore kindly requesting the Ministry of Finance to grant approval as in paragraph one (1) above.



APPLICATION FOR THE PROCUREMENT OF TAX AND CUSTOM DUTIES EXEMPTION IN FAVOUR OF THE ABOVE PROJECT

Ghana Ports and Harbours Authority (GPHA) and Jan de Nul Belgium signed an agreement for the development of Takoradi Port on the 20th of September, 2012 for an amount of €197 million with the Government of Ghana providing sovereign guarantee.

The Ghana Revenue Authority and the Ministry of Finance advised that Jan de Nul Belgium is not incorporated in Ghana and generally, no person can set out to do business in Ghana unless the person has registered with the Registrar-General's Department and with the Ghana Revenue Authority. Therefore, Jan de Nul, Ghana had to be incorporated and the contract had to be amended to reflect the new party to this contract.

Clause 1.13 of the Particular Conditions of the Contract provides as follows:

"Because the Employer is a government body, Contractor's preliminary estimation of prices does not include for local Ghanaian taxes and import duties and the Contractor is deemed exempted from such taxes and import duties. Should the Contractor be obliged to pay for local Ghanaian taxes and import duties, the Contractor shall be entitled to increase the preliminary estimation of prices with the amounts payable for local Ghanaian taxes and import duties upon finalization of the prices after completion of the FEED."

On the 19th of June 2013, the parties signed an agreement, amending the contract signed in September 2012. The effect of the amendment was to add Jan de Nul Ghana as an additional contractor and for Jan de Nul Ghana to have all the benefits and responsibilities of the original contractor, Jan de Nul Belgium.


