TOURISM ON THE 2002 ANNUAL ESTIMATES OF THE MINISTRY OF TOURISM

INTRODUCTION

The Minister of Finance on 21st February, 2002 presented to the House, the Government's Budget Statement and Financial Policy of the Government for the year ending 31st December 2002 in accordance with Article 179 of the 1992 Constitution of Ghana.

Pursuant to Standing Orders 140(4) and 159, the 2002 Annual Estimates of the Ministry of Tourism was referred to the Committee for consideration and report.

The Committee held discussions with the Deputy Minister of Tourism and officials of the Ministry, representatives of the Ghana Tourist Board and the Hotel Catering and Training Institute (HOTCATT). The schedule officer from the Ministry of Finance was also present and the Committee is grateful for his useful contributions.

MISSION STATEMENT OF THE MINISTRY

The Ministry of Tourism exists to formulate policies, the implementation of which would create an enabling environment, especially the friendliness of Ghanaians for the development of a sustainable Tourism atmosphere thereby contributing towards the enhancement of the country's socio-economic programmes. The Ministry also formulates policies, plans and draws up programmes for the development and promotion of domestic, national and international tourism.

OBJECTIVES

The Ministry is mandated to pursue the following objectives:

- Promote institutional and human resources capacity for quality service delivery
- ii. Promote, evaluate and monitor community involvement in tourism in order to spread its socio-economic benefits
- iii. To increase public understanding of tourism so as to encourage greater support for and participation in the tourism sector

- iv. To promote and market Ghana as a competitive and quality destination and support sub-regional efforts at tourism development
- v. To work out for the provision of adequate tourism infrastructure in collaboration with the relevant MDA's and the private sector.
- vi. To promote public and private sector participation to increase tourism investment
- vii. To establish an effective National Tourism Information System (NATIS) for information dissemination.

OBSERVATION

The Committee observed that there were duplicating of responsibilities within the sector. The Committee commends the Ministry for initiating some actions to redefine roles.

The Committee expressed concern about the need for the regional offices to be fully equipped in other to make them more effective in the performance of their duties. With this new budget the Committee hopes that the Ministry will improve upon its logistic problems.

The Committee also recommends that the Ministry should play a supervisory role whilst the various boards, are allowed to implement policies.

The Committee again expressed concern about the fact that the \$\psi 3\$ million earmarked for promotional adverts for the Ministry was woefully inadequate. The Committee was of the view that more money should be channelled into the development and promotion of tourism through direct advertising. The Committee would wish that more money is expended on the promotion and marketing of Ghana's tourism potentials to attract patronage.

CONCLUSION

In view of the fact that Tourism is a potential revenue source for the country, the Committee after analysing facts and figures recommends that the House approves the total sum of **Eleven** billion, one hundred and five million cedis (¢11,105,000,000) for the activities of Ministry of Tourism for the fiscal year 2002.
