FORESTS (ACHIMOTA FIREWOOD PLANTATION FOREST RESERVE) (AMENDMENT) INSTRUMENT, 2023

IN exercise of the power conferred on the President by section 2 of the Forests Act, 1927 (CAP. 157), this Instrument is made this 22nd day of May 2023.

Schedule to Order No. 31 of 1930 amended

The Forests (Achimota Firewood Plantation Forest Reserve) Order, 1930 (Order No. 31 of 1930) is amended by the substitution for the Schedule, of
